Were you one of the faithful planning on a good show at the North American Shipwreck and Dive Show, to be held Mar 18?

The prestigious show was unexpectedly cancelled this year, with no warning to anyone. Scheduled for a Saturday, the cancellation actually went out on the internet at their website just one week prior to the show. Bad enough that potential attendees had made commitments to go, but even presenters were caught unaware. One presenter was our own Bill Atkins, who got the word on the website while looking for other information.

William Lamping, person in charge, put out the following statement on Mon the 13th:

To all of our presenters and speakers:

It is with extreme difficulty that we are forced to announce the cancellation of the North American Shipwreck and Dive Show slated for March 18th in West Bloomfield, Michigan. We were forced to stop the show due to a last minute change in key issues that were agreed upon many months ago. Or so we thought.

This show was intended to be the premier show in the midwest area. We had excellent presentations that many were looking forward to, in addition to the varied exhibitors that offered a wide range of goods and services. Our sincere apologies to all of you presenters that worked hard on your really wonderful shows. We're truly sorry that you will not be able to share your passion and expertise at what we hoped would be a signature event.

For those of you that paid for travel arrangements in advance, please let us know if you will be charged a cancellation fee, and if so we will reimburse you.

Again, our deepest apologies to those that planned on attending. It is most frustrating for us to be put in this situation.

Compressor News-

Our compressor site transfer to Thomas Township is still a go; the exact moving date has not been determined. Pres Cunningham has the following agreement at present:

March 9, 2006

Mr. Don Cunningham

This is an agreement regarding the storage and use of the Saginaw Underwater Explorers Air Unit (SUEA).

We agree to the following;

1. The Thomas Township Fire Department and the Saginaw Underwater Explorers would "share" the use of an air compressor used to supply breathing air bottles. The SUEA unit agrees to pay for one air sample to be taken by a recognized firm equally agreed upon by both parties and the Fire department agrees to pay for any additional air testing required by code.
2. The Saginaw Underwater Explorers would pay for the installation cost of bringing electricity to the unit for its operation and Thomas Twp. Fire Department would pay for its annual electricity cost. The electrical work must be performed by the Townships' electrician, Leddy Electric. The operational costs, i.e. oil changes etc. would be equally split between both parties. When large expense items are needed i.e. motor overhaul, the fire department will pay a portion of the bill based on the hours used by the fire department.
3. The Saginaw Underwater Explorers will show proof of liability coverage including showing Thomas Township as co-insured.
4. The Thomas Township Fire Department will provide access to a room accessible from the exterior of the building for the use and storage of this unit.
5. The Saginaw Underwater Explorers will train a number of members of the Thomas Township Fire Department as "users" of the air system.
6. Saginaw Underwater Explorers shall remain the sole owner of the air unit and all related equipment.
7. Termination of this agreement can be made by either party with a 90 day written notice. The Fire department agrees to at least a one year minimum agreement for this arrangement or will pay half the cost of installing the system.
8. Both parties shall maintain a list of users and contacts.

Until notified of the move, call for fills.
